**2004 Divisional Championship  
Rules, Guidelines and Procedures**

All fencers in the 2004 Divisional Championships must be **CURRENT COMPETITIVE** members of the USFA and be *citizens of the USA, or have attained permanent resident status*. If you are not a current member or cannot verify your membership, you will have to join at the Divisionals in order to be allowed to fence. All fencers will be required to sign a waiver of liability which is also available on the division website. **Fencers under the age of 18 will not be allowed to compete if their waiver is not signed by a parent or legal guardian.** Full equipment checks will be performed. Please arrive early to accommodate this. A fencer whose equipment fails on strip will be given a yellow card.

**NEW QUALIFIER RULES ARE IN EFFECT:**

Starting with this Divisional Championship, the USFA has altered the rules for qualifying. The new USFA policy is as follows:

- In order to qualify for Division II, a fencer must:
  - Place in the top 25% of the 2004 Division Championship; or
  - Qualify for the U16 National Championship; or
  - Qualify for the Division I-A or U19 National Championships.
- In order to qualify for Division II, a fencer must:
  - Place in the top 25% of the total number of D's, E's and U's in the 2004 Division Championship; or
  - Qualify for the U16 National Championship; or
  - Qualify for the Division I-A or U19 National Championships.
- In order to qualify for Under-16, a fencer must:
  - Place in the top 25% of the 2004 Divisional Under-16 Championship.
- In order to qualify for Y-14, a fencer must:
  - Place in the top 25% of the 2004 Divisional Y14 Championship.

**2004 Division Business Meeting**

At the conclusion of the events on Saturday, April 3, 2004, the 2004 Annual Business Meeting will be held. Business matters will be discussed and voted on including bylaws amendments and election of officers. A tentative agenda is attached.

If you are unable to attend, you may appoint a proxy to vote in your stead at the meeting. Your proxy form should include your name, date of birth, who you are appointing as your proxy, his or her date of birth and both your and their signatures. The Division Officers reserve the right to exclude any proxies that do not meet the minimal requirements. Proxy forms must be presented to the division secretary before the close of the final fencing event for the day.

  - G. Proposed Bylaw Amendment #5: "To amend Article IX of the ALM Bylaws to state, "...complete tournament information including all participants' names, **dates of birth**, classification, club representations, and placement in the event.""
  - H. Proposed Bylaw Amendment #6: "To amend Article V of the ALM Bylaws to state, "Notice of all meetings shall be by letters to the membership mailed at least 30 days before the annual meeting is to be held."
