NATIONAL MEDAL FOR ALM

For the last 10 years, the ALM has boasted at least one national medal per year. The most recent run began at Summer Nationals 2001, where Evelyn Scarborough started her national medal collection with a bronze in Div 3 Women's Epee. She took another bronze in the Div 2 in Sandy Utah. At the same tournament, Lowery Rogers scored a national medal with her 6th place in Div 3 Sabre. Jack Harkey grabbed 7th place in the Div 3 Men's Foil in Reno, NV. Scarborough finished out the year of medals with her 7th place finish in the Junior Women's Epee at Summer Nationals in Greenville.

The 2002-2003 season saw Dorothy Hubbard's impressive bronze at the Junior NAC in Greenville. Then, after qualifying to fence the World, a hand injury sidelined Scarborough from the Junior World Team and the rest of the season.

Last season the division celebrated its first international medal as Scarborough added yet another bronze to her collection from the Junior World in Louisville. Shortly following was Dorothy Hubbard's 8th place finish at Junior Olympics. With Harkey, Hubbard, Rogers, and Scarborough all aging out of Junior and classing out of Div 2, it looked as though our division would have a season without medals until this month in

Team Information: Teams must be made up of individuals in the same primary club who have represented this club at least one time in competition during the current season. This one time could include the same day on which the team event occurs. Individuals do not qualify for teams, clubs qualify for teams with the potential for individual fencers who represent the club at nationals to be completely different from those who represent the club at the qualifier. Five clubs are allowed to qualify without fencing, therefore, if less than 6 clubs compete, all qualify and no fencing will occur. To help defray tournament expenses, no trophies will be given to non-contested events. Team events are seeded according to how that fencer finished in the open event of the same weapon. No division patches are given for team events, but will be awarded for non-contested individual events. Qualifying Information for the 2005 Summer National Championships

There are NO alternates for any competition at the USFA Summer Nationals Championship tournament.

Classifications can be awarded at a Division/Section Summer Nationals qualifying competitions and must be noted on the qualifying report form. Cadet and Y14 events must be C1 or greater for a classification to be awarded. The USFA office will verify eligibility, membership, and the accuracy in determining the number of qualifiers in each event.

Athletes are permitted to fence in their Division/Section qualifying competitions only IF:

- 1) The athlete is a U.S. citizen OR permanent resident of the United States and a current competitive member of the USFA **And**
- 2) The athlete's birth year falls in that age bracket **OR**
- 3) The athlete is on the national rolling point standings in the next younger age bracket.
 - a. Example: For a fencer, born 1993, to be eligible to fence in the Division's Cadet qualifying competition, the fencer must be listed on the current Youth 14 point standings. Current is defined as the point standings at the time of the qualifying competition.
 - b. Example: For a fencer, born 1993, to be eligible to fence in the Section Junior qualifying competition the fencer must be listed on the current Cadet point standings. Current is defined as the point standings at the time of the qualifying competitions.

SUMMER NATIONALS CHAMPIONSHIPS

Fencers must be U.S. citizens OR permanent residents of the United States and current competitive members of the USFA who **MUST** meet qualification standards specified for each category to enter the USFA Summer Nationals Championships.

Any fencer who is not a citizen or is a permanent resident who has represented another country in the last three years and who has not yet been granted permission to represent the USA is not eligible for any USFA National Championship competition, individual or team, including Division and Section qualifying competitions. A foreign fencer who is in the US on a visa is **NOT** eligible to fence in any National Championships, individual or team, or associated Division or Section qualifying competitions. On the USFA membership list and membership card a foreign fencer is designated with an asterisk after their first name (*). If you have conflicting information about whether a fencer is foreign, contact the USFA at (719) 866-4511 ext. 2.

Fencers must have a USFA "Competitive Member" card with an expiration date of 7/31/05 or later. Automatic qualifiers will be posted on the USFA Web site and updated periodically.

NRPS stands for National Rolling Point Standings, which can be viewed on the US Fencing website.

In determining the number of qualifiers, the number of competitors is the total number of fencers who competed in the qualifying competition who are eligible to fence in the Championships. Once the number of qualifiers is determined, those who have already qualified to the Championships in that event (athletes determined to be automatic qualifiers) are skipped in determining those who have become qualifiers in that competition. For example, if there are 20 competitors in the qualifying competition, of which four have already qualified for that particular championships event, those four are skipped in determining the five qualifiers from that competition. Example: If the ones who have already qualified are 1st, 3rd, 6th, and 7th, then the qualifiers are those who have placed 2nd, 4th, 5th, 8th and 9th.

Fencers must be born no later than 1992 **AND**

- Place in the top 25% (with a minimum of 8) at the 2005 Senior Section Championships **OR**
- Placed in top 8 at the 2004 Division I-A National Championship **OR**
- Placed in top 4 at the 2004 Division II National Championships **OR**
- Be the current 2005 Under – 19 Section Champion

**UNDER-19
CHAMPIONSHIPS**

Fencers must be born between 1986 and 1992** **AND**

- Place in the top 25% at the 2005 Under-19 Section Championships **OR**
- Be on the Junior (Under –19) point standings as of May 1, 2005 **OR**
- Be in the top 16 of the Cadet (Under – 16) point standings as of May 1, 2005

**DIVISION II
CHAMPIONSHIPS**

Fencers must have a classification in the weapon of “C”, “D”, “E”, or Unclassified at the time of the qualifying competition **AND** born no later than 1992 **AND** –

- Place in the top 25% of the 2005 Division Qualifying competition **OR**
- Qualify for Division I-A National Championships **OR**
- Qualify for the 2005 Under – 19 National Championships in that weapon **OR**
- Qualify for the 2005 Under – 16 National Championships in that weapon **OR**
- Placed in the top 4 at the 2004 Division III National Championships

**DIVISION III
CHAMPIONSHIPS**

Fencers must have a classification in the weapon of “D”, “E”, or Unclassified at the time of the qualifying competition **AND** have been born no later than 1992 **AND** –

- Qualify for Division II
- Place in the top 25% of the total number of “D”, “E” or “U” fencers competing in the 2005 Division’s Division II Qualifying competition (when Division II and Division III qualifying competition is held together) **OR**
- If separate Division III qualifying competition is held by the Division, then the top 25% of the field will qualify for Division III National Championships **OR**
- Qualify for Division I-A National Championships in that weapon **OR**
- Qualify for the 2005 Under – 19 National Championships in that weapon **OR**
- Qualify for the 2005 Under – 16 National Championships in that weapon

**UNDER-16
CHAMPIONSHIPS**

Fencers must be born between 1989 and 1992** **AND**

- Be on the Cadet point standings as of May 1, 2005 **OR**
- Place in the top 25% of the Division’s U – 16 qualifying competition **OR**
- By Board action, any fencer who has qualified for the Under-19 National Championships becomes an automatic qualifier for the Under-16 Championships (BOD, 10/04) **OR**
- Be in the Top 8 of the Youth 14 point standings as of May 1, 2005

**YOUTH 14
CHAMPIONSHIPS**

Fencers must have been born between 1990 and 1993** **AND**

- Be on the Youth 14 point standings as of May 30, 2005 **OR**
- Place in the top 25% of the Division Youth 14 Qualifying competition

YOUTH 12 OPEN

Fencers born between 1992 and 1995** **AND**

- Fenced in one Regional Youth Circuit or one Super Youth Circuit or NAC Youth in the 2004-2005 season in the age and weapon category (categories) in which the athlete requests entry acceptance **OR**
- Be on the Youth 12 point standings as of May 30, 2005
- Fencer must state on the Summer Nationals Entry Form the competition(s) at which he or she fulfilled the requirement. Failure to do so will be basis for rejection of the entry. *

YOUTH 10 OPEN

Fencers born between 1994 and 1997 **AND**

- Fenced in one Regional Youth Circuit or one Super Youth Circuit or NAC Youth in the 2004-2005 season in the age and weapon category (categories) in which the athlete requests entry acceptance **OR**
- Be on the Youth 10 point standings as of May 30, 2005

* Fencer must state on the Summer Nationals Entry Form the competition(s) at which he or she fulfilled the requirement. Failure to do so will be basis for rejection of the entry. *

VETERAN

Any current competitive member born 1964 or earlier who has competed in

- 2005 Section Championships **OR**
- 2005 Division qualifying competition for Division II and/or Division III Championships {only those with a “C” classification or lower (D, E, or U) may compete} **OR**
- Any NAC During the 2004-2005 season
- Fencer must state on the entry the competition by which he or she complied with qualification criteria. Failure to do so will be basis for rejection of entry.

- Be on the National Senior point standings on May 1, 2005 **OR**
- Be in the top 8 of the Junior (U-19) point standings on May 1, 2005 **OR**
- Be in the top 4 of the Cadet (U-16) point standings on May 1, 2005 **OR**
- Placed in the top 8 in the 2004 Division I-A National Championships **OR**
- Placed in the top 4 in the 2004 Division II National Championships **OR**
- In men's epee and women's epee – be one of three athletes named by the U.S. Modern Pentathlon Association

****Athletes are permitted to fence in their Division or Section Qualifying competitions for the Summer Nationals IF:**

- The athlete's birth year falls in that age bracket OR
- The athlete is on the national rolling point standings in the next younger age bracket

National Championship Appeal Procedure

In exceptional cases, subject to approval by the USFA Executive Committee, a member of the USFA in good standing may be permitted to qualify to the Summer Nationals Championships or Summer National Championships by appeal. No petition may contravene the results of a qualifying competition – a fencer who has fenced in the competition without withdrawing due to valid medical reasons cannot then petition to disregard or override those results.

The following criteria and procedures are applicable to filing an appeal.

- An appeal may be filed by a fencer who qualified (by means of competition or appeal) to that same competition in the prior season or whose competitive record during the current fencing season indicates a strong possibility that (s)he would have qualified had (s)he been able to compete in the qualifying competition but:

1. Was unable to compete in the qualifying competitions this season, **OR**
2. Did compete and had to withdraw because of a disabling injury or illness.

(Note: Mere attendance at an out-of-town school during the qualifying competition shall not constitute inability to compete.)

All appeals must be made in writing to the Director of National Events, USFA National Office, 1 Olympic Plaza, Colorado Springs, CO 80909-5774. Such appeals **are to be filed within five business days** following the competition at which the petitioner could have qualified.

- Relief from this deadline will be granted only when the specific qualifying competition is held less than two weeks prior to the entry deadline. Under no circumstances will petitions be accepted if received after the entry deadline for the Championships.

The appeal must be accompanied by:

1. A non-refundable fee of \$30.00, payable to the USFA.
2. A written statement that gives the specific details of the dates, reason for absence or withdrawal, and other pertinent facts. Written notice from the attending physician and/or statement from the Bout Committee must substantiate any medical reasons if the medical reason required withdrawal from the qualifying competition.
3. A summary of the fencer's significant competitive results during the past year. In particular, results in previous National Championships and recent North American Cup competitions should be noted.
4. Evidence that a copy of the petition has been submitted to the Chair or Secretary of the Division or Section that hosted the qualifying competition. If the basis for the petition does not correspond with information available to the Division or Section officer, then the USFA expects the officer to so notify the national office in writing. –
5. A completed entry form for the competition with the correct registration and entry fees. If the petition is not approved, these fees associated with the entry will be refunded.
6. A self-addressed, stamped envelope/or fax back sheet for reply to the appeal if athlete does not have a current e-mail address; otherwise responses to the appeal will be made by e-mail.

Petitions that do not meet these requirements will not be considered.

Decisions on petitions will be based upon the validity of reasons given for absence or withdrawal and the probability that the fencer would have qualified had (s) he competed in the qualifying competition to its conclusion, based on results achieved in other competitions.

The appropriate Division and/or Section Officer will be notified by the Director of National Events of submission of appeals from athletes from that Division or Section, depending on specific competition for which appeal is being filed. The officer can then file a statement recommending denial of appeal and reasons thereto. Otherwise, it will be assumed the officer has no objection to approval of appeal.

If a fencer is permitted to enter a National Championship competition by this appeal procedure, the fencer's entry will in no way affect the number of qualifiers from the Division or Section involved.

Appeal Checklist (Additional documentation may be requested by the USFA)

- Non-refundable petition fee of \$30.00
- Letter from the athlete outlining the reason for the appeal with a summary of significant competition results during the last year
- Copy of the letter sent to a Division/Section Officer notifying them of the Appeal
- Letter from a physician if the petition is for medical reasons (*if needed*)
- Letter from the Bout Committee Chair **if a medical withdrawal** occurred during the qualifier (*if needed*)
- A self-addressed stamped envelope, email address or fax back sheet for reply to the appeal
- Appeal submitted within five business days of the qualifier
- Championship Entry form and payment

If your petition is incomplete, it will be returned to you unprocessed.

The 2005 USFA Summer National Championships will be held July 1-10, 2005 at the Sacramento Convention Center in Sacramento, CA

You must be a US citizen or permanent resident who is eligible to represent the United States at international competitions. If you have represented another country in international competitions and have not received approval from the FIE to represent the United States, you are NOT eligible to fence in any USFA National Championships. You must submit your entry using the official Summer National Championships Entry Form, a copy of which will be posted on the USFA web site. The list of automatic qualifiers will be posted on the USFA web site. Fencers may enter only one competition per day. If the fencer fails to report when called for a bout, the fencer is excluded from the competition.
